OUR MISSION

We advocate for human rights, social justice and inclusion in the United States and around the world by inculcating a culture rooted in human rights through public education, advocacy, and the arts.

WHAT WE DO

We advocate for women and LGBTQIA+ rights, for the separation of religion and state, and for freedom of conscience. In advancing these human rights values, MPV provides an alternative progressive voice to these issues by participating in civil discourse, engaging with the media and government entities, with public educational forums as well as cultural events, and by partnering with both Muslim and non-Muslim progressive organizations. By securing the Department of Public Information, and the Economic and Social Council Special Consultative Status at the United Nations, we challenge much of the human rights abuses in Muslim societies.

WHAT WE BUILD

Starting in Los Angeles in 2007, we have been building a progressive Muslim movement which has now expanded to San Francisco, Washington D.C., Atlanta, New York, Chicago, and Boston. In 2017, MPV founded Alliance of Inclusive Muslims, an umbrella human rights organization with affiliates and partners in Argentina, Brazil, Chile, Canada, Denmark, France, Germany, U.K., Tunisia, Burundi, Democratic Republic of Congo, Rwanda, Kenya, Uganda, India, Bangladesh, Pakistan, Malaysia, Indonesia and Australia.

Our Founder

Ani Zonneveld is a writer, singer/songwriter, founder and President of MPV, a strong supporter of freedom of expression, women's and LGBTQ rights. Ani promotes these values at the United Nations by challenging human rights abuses in the name of Islam and by offering an inclusive understanding based on universal human rights. Ani is on the U.N. Inter-agency's Faith Advisory Council and co-chairs its Gender Working Group. She is the co-editor of MPV's first book, an anthology titled "Progressive Muslim Identities – Personal Stories from the U.S. and Canada" and executive producer of a video series "LGBT+ Rights in Islam". She has a TEDx talk titled – Islam: As American As Apple Pie, and is the subject of a documentary title "al-imam" featuring her activism, screened at the American Pavilion at the Cannes Festival, 2019.

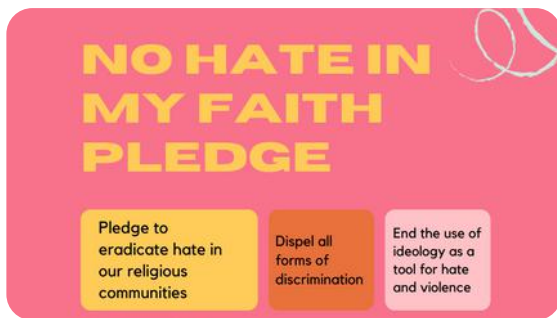

ADVOCACY

MPV is actively engaged in advocacy efforts at the grassroots, and national level. Our advocacy work includes public educational forums and filing amici briefs with like minded organizations on issues against child and forced marriages and female genital mutilation, and in favor of women's reproductive rights, the rights of the LGBTQIA population, and for the separation of religion and state.



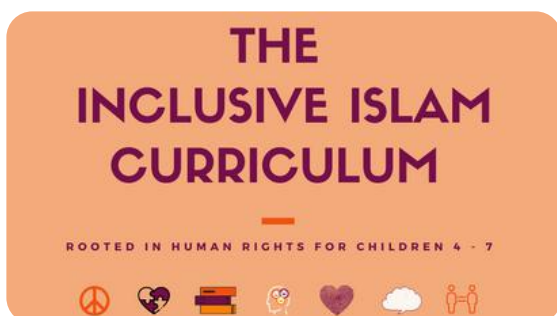
NO HATE IN MY FAITH

After years of homophobic indoctrination, a self-hating gay Muslim killed 49 people at Pulse. #NoHateInMyFaith was launched to proactively advocate against hate on the basis of religion, sexual identity, and race. MPV calls upon ALL people to become proactive advocates within their communities to dispel all forms of discrimination, hate, and violence in the name of religion.



MARRIAGE SERVICES

Since the founding of MPV, we have helped hundreds of couples of diverse faith backgrounds formalize their marriage vows while incorporating the traditions of Islam. Our services include a consultation, a custom marriage ceremony, for interfaith as well as same sex couples, a personalized *nikah* contract, and a beautifully designed marriage certificate.



CURRICULUMS

Inspired by the United Nations' Sustainable Development Goals, we collaborated with partners in the U.S. and in Burundi to develop two set of curriculums that are specific to their communities. Each curriculum utilizes a student-centered Whole Child Approach that inculcates human rights values, the environment, critical thinking, and for freedom of belief.

INTERNATIONAL PROGRAMS

UN ADVOCACY



In 2018, MPV secured Economic and Social Council Special Consultative Status at the United Nations elevating recognition and support for MPV's work to new levels. Through various UN legal mechanisms, MPV challenges various human rights abuses perpetrated by Muslim majority countries in the name of Shari'a law. MPV's areas of focus are gender equality, LGBTQIA+ rights, freedom of expression, and freedom of religion and belief.

#IMAMSFOR SHE



#ImamsForShe is a global MPV initiative launched in March 2015 to address misogynist interpretations of Islamic scripture and traditions that have led to women and girls rights violations and their sub-human status across Muslim-majority countries and within Muslim communities in the West. With 548 #ImamsForShe Champions in our network in Burundi, Democratic Republic of Congo, Rwanda and Uganda, we have impacted positively thousands of lives.

ALLIANCE OF INCLUSIVE MUSLIMS



MPV is a founding member of Alliance of Inclusive Muslims (AIM), a collective of progressive Muslims across all nationality, race and sectarian affiliations, spanning six continents. As a member of AIM, MPV helps to consolidate and amplify thematic issues of human rights, freedom of expression, and freedom of/from religion and belief.

NGO COLLABORATION



MPV collaborates with other human rights organizations in various forms including but not limited to organizing forums and contributing to research studies. We focus on issues of apostasy and blasphemy laws, and countering radicalism, and is a member of number of committees and working groups including Global Campaign for Family Law Reform, the UN's Faith Advisory Council, ERA Coalition, and End FGM/C Network.

MALIHA KHAN

Maliha Khan is native New Yorker, based in Washington D.C. Maliha has been involved with MPV since 2011 and serves as the head of MPV's DC chapter as well as Co-Chair of the MPV Board of Trustees. In college, Maliha established the Pace University chapter of Project Nur – a student-led initiative promoting principles of human and civil rights in the U.S. and around the world. She also worked on civil rights issues as a law clerk for the Council on American-Islamic Relations (CAIR). Maliha received her JD and Masters in International Affairs at American University. In 2016, Maliha joined the U.S. Department of Commerce to work on international trade law and policy matters. In 2020, she joined the law firm Kelley Drye & Warren where she practices international trade law.



KEVIN JENNINGS

Kevin Jennings is the Chief Executive Officer of LAMBDA Legal. A First-Generation college graduate, Jennings received his B.A. magna cum laude in History from Harvard in 1985 and then became a high school history teacher. In 1988, he helped students at Concord Academy to create the nation's first Gay-Straight Alliance, leading him two years later to found the Gay, Lesbian, and Straight Education Network (GLSEN). In 2009, Jennings was named Assistant Deputy Secretary for Safe & Drug-Free Schools in President Obama's Education Department. In 2011, Jennings left the Obama Administration to become Executive Director of the nonprofit Be the Change and to help launch its Opportunity Nation campaign, aimed at reducing economic inequality and promoting social mobility in America. Jennings has a long record of community leadership. He is the author of seven books, including the 1997 Lambda Literary Award-winner *Telling Tales of Out School*.

As a career diplomat, Van Schreven served from 2002 to 2006 as the Netherlands Ambassador in Damascus (Syria) and was previously posted in different diplomatic levels at the Netherlands Embassy in Caracas (Venezuela) and the Permanent Representation to the EU in Brussels. He was also Deputy Director for European Integration at the Ministry for Foreign Affairs in The Hague. He gained an MBA at INSEAD and holds a degree in Economics from the University of Geneva.



SAMINA ALI

Samina Ali is an award-winning author, curator, and popular speaker. Her debut novel, *Madras on Rainy Days* (Farrar, Straus, Giroux), was the winner of France’s prestigious Prix Premier Roman Etranger Award and a finalist for the PEN/Hemingway Award in Fiction. *Poets & Writers Magazine* named it a Top Debut of the Year. The recipient of fiction awards from the Rona Jaffe Foundation and the Barbara Deming Memorial Fund, she has been featured in *The Economist*, *The Guardian*, *Vogue*, National Public Radio (NPR) and elsewhere. SALEEMAH ABDUL-GHAFUR

Saleemah Abdul-Ghafur is currently the Director and Chief of Staff in the Office of the Chief Communications Officer at the Bill and Melinda Gates Foundation. For eight years, she was the Director of The African Leaders Malaria Alliance (ALMA), a first-of-its-kind leadership coalition comprised of all African heads of state, working to eliminate malaria. Saleemah was part of a national movement to end gender discrimination in the American Muslim community by participating in a civil action to give women space and voice in American mosques where they have traditionally been banned. Abdul-Ghafur edited *LIVING ISLAM OUT LOUD: American Muslim Women Speak*, the first anthology collecting the voices of American Muslim women.



AMIR HUSSEIN

Dr. Amir Hussain is Associate Professor in the Department of Theological Studies at Loyola Marymount University in Los Angeles, where he teaches courses on world religions. His own particular speciality is the study of Islam, focusing on contemporary Muslim societies in North America. Although born in Pakistan, Amir immigrated to Canada with his family when he was four. His academic degrees (BSc, MA, PhD) are all from the University of Toronto where he received a number of awards, including the university's highest award for alumni service. Amir's PhD dissertation was on Muslim communities in Toronto. In 2008, Amir was chosen by vote of LMU students as the Professor of the Year. Amir's new book is an introduction to Islam for North Americans entitled *Oil and Water: Two Faiths, One God* (Kelowna: Copper House, 2006).



BLAIR IMANI

Blair Imani is a critically-acclaimed historian, social activist, public speaker, educator and influencer. She is the author of two historical books *Modern HERstory: Stories of Women and Nonbinary People Rewriting History* (2018) and *Making Our Way Home: The Great Migration and the Black American Dream* (2020). Blair Imani educates using a variety of social media platforms in addition to speaking at universities and organizations around the world. Hailing from Los Angeles, California, Blair Imani attended Louisiana State University where, in 2014, she founded Equality for HER, a non-profit organization that provided resources and a forum for women and nonbinary people to feel empowered. A highly sought-after public speaker, Blair Imani has appeared on FOX News and MSNBC and has presented at colleges and universities, at progressive conferences around the world.
